St. Peter's N.S.: Child Safeguarding Statement and Risk Assessment

Child Safeguarding Statement

St. Peter's N.S. is a primary school providing primary education to pupils from Junior Infants to Sixth Class. We also have two autism classes.

In accordance with the requirements of the <u>Children First Act 2015</u>, <u>Children First: National Guidance for the</u> <u>Protection and Welfare of Children 2017</u>, the Addendum to Children First (2019), the <u>Child Protection</u> <u>Procedures for Primary and Post-Primary Schools (revised 2023)</u> and <u>Tusla Guidance on the preparation of</u> <u>Child Safeguarding Statements</u>, the Board of Management of St. Peter's N.S. has agreed the Child Safeguarding Statement set out in this document.

- 1 The Board of Management has adopted and will implement fully and without modification the Department's *Child Protection Procedures for Primary and* Post-Primary Schools (*revised 2023*) as part of this overall Child Safeguarding Statement
- 2 The Designated Liaison Person (DLP) is Duncan Mc Carthy
- 3 The Deputy Designated Liaison Person (Deputy DLP) is Brid Bolster
- 4 The Relevant Person is Duncan Mc Carthy

(The relevant person is one who can provide information in respect of how the child safeguarding statement was developed and will be able to provide the statement on request. In a school setting the relevant person shall be the designated liaison person.)

5 The Board of Management recognises that child protection and welfare considerations permeate all aspects of school life and must be reflected in all of the school's policies, procedures, practices and activities. In its policies, procedures, practices and activities, the school will adhere to the following principles of best practice in child protection and welfare:

The school will:

- recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;
- fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare of children;
- fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters;
- adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
- develop a practice of openness with parents and encourage parental involvement in the education of their children; and
- fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

6 The following procedures/measures are in place:

• In relation to any member of staff who is the subject of any investigation (howsoever described) in respect of any act, omission or circumstance in respect of a child attending the school, the school adheres to the relevant procedures set out in Chapter 7 of the *Child Protection Procedures*

for Primary and Post Primary Schools (revised 2023) and to the relevant agreed disciplinary procedures for school staff which are published on the gov.ie website.

- In relation to the selection or recruitment of staff and their suitability to work with children, the school adheres to the statutory vetting requirements of the <u>National Vetting Bureau (Children and Vulnerable Persons)</u> Acts 2012 to 2016 and to the wider duty of care guidance set out in relevant Garda vetting and recruitment circulars published by the Department of Education and available on the gov.ie website.
- In relation to the provision of information and, where necessary, instruction and training, to staff in respect of the identification of the occurrence of harm (as defined in the 2015 Act) the school-

- All registered teachers employed by the school are mandated persons under the Children First Act 2015.
- In accordance with the Children First Act 2015 and the Addendum to Children First (2019), the Board has carried out an assessment of any potential for harm to a child while attending the school or participating in school activities. A written assessment setting out the areas of risk identified and the school's procedures for managing those risks is included with the Child Safeguarding Statement.
- The various procedures referred to in this Statement can be accessed via the school's website, the gov.ie website or will be made available on request by the school.

- Risk of harm to children with SEN who have particular vulnerabilities
- Risk of harm to a child while a child is receiving intimate care
- Risk of harm due to inadequate Code of Behaviour
- Risk of harm in one-to-one teaching
- Risk of harm caused by member of school personnel communicating with pupils in an inappropriate manner via social media, texting, digital device or other manner
 Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner

- The school implements in full the SPHE curriculum
- The school has an Anti-Bullying Policy which fully adheres to the requirements of the Department's *Anti-Bullying Procedures for Primary and Post-Primary Schools* The school adheres to the requirements of the Garda vetting legislation and relevant DES circulars in relation to recruitment and Garda vetting
- The school complies with the agreed disciplinary procedures for teaching
- staff The school has a Special Education Policy
- The school has an Intimate Care Policy in respect of students who require such
- care The school has in place procedures for the administration of medication to

pupils • Encourages staff to avail of relevant training

- Encourages board of management members to avail of relevant
- training Maintains records of all staff and board member training
- The school has in place a Code of Behaviour for pupils
- The school has an Acceptable Use Policy in place, to include provision for online teaching and learning remotely, and has communicated this policy to parents The school has developed a Critical Incident Management Plan.
- When students are undertaking School Placement, standard placement procedures will be followed (e.g. provision of Garda Vetting). Class teacher will be present at all times during sessions by external providers (e.g. coaches and parents).
- Coaches will provide Garda vetting before commencing coaching sessions

- The school has a supervision policy to ensure appropriate supervision of children during, assembly, dismissal and breaks. The policy will be amended to include supervision in respect of specific areas such as toilets.
- The school has developed an Intimate Care Policy and will develop care plans for pupils, as required.
- The school has procedures in place to cover accident/injuries.
- The school has a system to ensure all staff have access to the school policies.

Important Note: It should be noted that risk in the context of this risk assessment is the risk of "harm" as defined in the Children First Act 2015 and not general health and safety risk. The definition of harm is set out in Chapter 4 of the *Child Protection Procedures for Primary and Post-Primary Schools (revised 2023)*

In undertaking this risk assessment, the board of management has endeavoured to identify as far as possible the risks of harm that are relevant to this school and to ensure that adequate procedures are in place to manage all risks identified. While it is not possible to foresee and remove all risk of harm, the school has in place the procedures listed in this risk assessment to manage and reduce risk to the greatest possible extent.
